## Plan Summary [2024-25]

### General Information

Chrysalis Charter School is a public K-8 charter school that is free and non-discriminatory. Our mission -- “Encouraging the light within each student to shine brighter” -- shapes every aspect of Chrysalis from the small size of our school, to the way we teach, to the close relationships we form with families. While some students shine brightest in our full-time classroom program with experiential learning in all subjects, others shine brightest through homeschooling where a teacher works alongside families to design and implement a program tailored to fit the student, with the option of field studies classes. We offer before and after-school care as well as bus service from several locations in Redding. Our program is characterized by the following core educational philosophies:

- teaching for understanding;
- kind environment; responsive teaching;
- fostering curiosity, initiative, and an inquiry mindset;
- immersion in nature;
- community, global awareness, and citizenship; and
- teacher power and choice.

### Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

As a whole, Chrysalis remains a strong option for a well-rounded education for our students. 90% of our parents believe their students are experiencing a well-rounded education and 95% of our parents believe that the staff is their partner in educating their students according to our Family Survey conducted in February 2024. 88% of our students rated their Sense of Belonging favorable in the Student Climate survey conducted in February 2024. On the CA Dashboard, our students as a whole were 9.8 points above standard for ELA. Our students are growing each year as well. At the end of the 2022-23 school year the median percent growth for ELA among our students was 137% in ELA and math was 114% according to our I-Ready Diagnostics.

Areas where there is room for improvement include:

Chronic Absenteeism - Like most of the state and country, our students are struggling with lower attendance rates after the COVID-19 pandemic. All of our student groups were rated in the "Orange" Level of the CA dashboard with 11.4 % of our students chronically absent. Socioeconomically Disadvantaged Students - perform lower than their peers in both ELA and Math, both in the Orange Level Performance Group, 28.9 points below standard for ELA and 65 points below standard in Math.

Math is another area where there is room for improvement, testing as a whole 28.1 points below standard for our general population. Teachers in 5th - 8th grades have been working with the rural math collaborative this year, and math has been a focus area for improvement for our 4th-grade teacher as well. The focus for our teachers has been on implementing practices from Building Thinking Classrooms through the Rural Math Collaborative and our 6th - 8th grade teachers are switching math curriculums to Inspiring Connections for the next three years to better align with practices they have been working on through their professional development. While our ELA scores reflect strong growth in our students, our CAASPP writing scores were an area of weakness in 2022-23 CAASPP testing. The teachers have voted to purchase the Step up To Writing Curriculum for the the entire school along with professional development for that program implementation.

STUDENTS	Students complete quarterly KELVIN surveys as well as a yearly survey on campus life. In addition, our house system and student council allow for students to take leadership roles in activities they would like to see at school and execute them.

As a teacher-powered school, the teachers have a strong voice in our LCAP goals and actions. Through our analysis of CAASPP data, we have chosen to adopt a common writing program for K-8 along with professional development. Our newer teachers have all enjoyed and benefited from the science coaching we have employed this year and have requested that continue for at least the next year. Another area of need that was noted was in our math program, and that is reflected in our purchase of an updated CPM curriculum, Inspiring Connections, for our 6th - 8th-grade students. Our K-5 teachers are eagerly awaiting the release of new math curriculum to align with the updated math framework and ELA curriculum that aligns with their updated practices around the Science of Reading. Most of the suggestions from parents were able to be implemented this year, including increasing school sports, developing common calendars for sports, and communicating rubrics for writing to families. The most common form of feedback from our parents is "Keep doing what you're doing, we love it here!" That is reflected in our continued actions written into our LCAP, including school counselor time, a focus on science, and a continued enhancement program to meet the needs of all students. The community focus of our House System in 5th - 8th grades has helped to build our middle school community and enrollment, and this too will be continued. An area of need that will still need to be decided upon during this LCAP cycle is a common SEL program for all grades.

  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.  
  
The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
  - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
